4. **Status**

Round 4 of the 2009 Ontario Performance Rally Championship (OPRC)

## 5. Description of Event

This is a performance rally consisting of 8 stages, to be run over closed roads, linked by transit sections with liberal time allowances. All competitive driving will be confined to gravel stages. Total length of the route will be approximately 210 kilometers, including about 106 kilometers of stage (51% stage). Distances and number of stages are subject to change.

Descriptive stage notes written by Tom McGeer will be offered to all competitors. Optional two-pass recce will be permitted for each stage. (See section 14)

## 6. Schedule

The organizers reserve the right to make changes in the location of events and/or the schedule if it becomes necessary. Competitors will be notified of any such changes as early as possible, in the manner prescribed by the regulations. All times are given EDT (Eastern Daylight Savings Time).

## 7. Rally Headquarters

The official Can-Jam Motorsports Black Bear Rally Headquarters will be at the Mayo Township Community Centre, Mayo Lake Road, McArthur's Mills, Ontario. The rally Headquarters will be the location for Registration while Technical Inspection, Rally Start/Finish and the Service Park will be located as per the attached map. The official notice board will be located inside the Community Centre. McArthur's Mills is located 25 km east of Bancroft, on Hwy 28 East.

## 8. Rally Area

The Can-Jam Motorsports Black Bear Rally takes place in the highlands of Southern Ontario. The entire route is contained within the following:

## 9. Entries

If mailing your entry, allow 5 days to reach the Registrar. Entries may be faxed to the registrar only if paying by credit card. Online, faxed or mailed entries received up to 1600 hrs on June 7, 2010 will be included in the Seeded Draw, along with those received by hand at the MLRC Mini Rally at the Husky House Restaurant, Intersection of Hwy. 400 & 88 (Exit 64A) prior to 1830 hrs. Entries will be accepted in person up until the close of registration on Saturday, June 12, 2010 at 0900 hrs.

## 10. Maximum number of Entries

The Maximum number of entries will be 35. If more than 35 entries are received, starters will be determined on a "first pay/first serve" basis (i.e.: payment must be received before your entry is considered).

## 11. Entry Fees

The standard entry fee (see article 11.1) is \$450.00 CDN. Or USD for US entries) Visa payment will be accepted using our online entry system available at <http://www.mlrc.ca/blackbear/index.html> in the Competitor section. For late entries, see section 11.1. Accommodation and fuel are not included.

All cheques or money orders must be made payable to "Maple Leaf Rally Club". Entries must be sent to the Registrar (see section 3). Visa entries may be faxed to 416-386-0855 until June 10, 2010 at 1400.

\* NOTICE TO US ENTRANTS: If you are sending your entry with a cheque, please pay the amount shown above in US funds. If you wish to pay with a credit card, then the transaction will be processed in CDN dollars and exchanged to US funds at the time the transaction is processed by your credit card company. In this case you are likely to get a more favorable exchange rate than that quoted above. The Black Bear Rally cannot guarantee the exchange rate.

### 11.1 Late Entry Fees

Entries will be accepted at the Standard Fee until 1830 hrs June 7, 2010. Entries that are not paid in full at this time are considered late and the Late Entry Fee of \$500.00 (\$500 USD for US Entries) will be charged and the entry will not be included in the seeded draw.

### 11.2 How to Enter

After April 30, 2010 0900 hrs, entries can be remitted in the following ways:

### 11.3 Refunds

Refunds for withdrawn entries will be in accordance with the General Competition Rules of CARS. A 100% refund will be made if notice of withdrawal is given at least 48 hours before the opening of Registration (i.e. before 1500 hrs June 9, 2010). In accordance with CARS General Competition Rules (GCR's) Organization of Events 4.9 – Page A-9):

### 11.4 Withdrawal

An entry may be withdrawn:

- a) without penalty up to 48 hours before the start of registration;
- b) with up to 25% of the entry fee in penalty, less than 48 hours before the start of registration (percentage at the organizer's discretion); and
- c) with up to 100% of the entry fee in penalty after the opening of registration (percentage at the organizer's discretion).

The withdrawal shall be made to the organizer by email or by telephone. An entrant or competitor accepted to take part in a competition who withdraws other than in the above manner or who does not take part in that competition but takes part in another on the same day may be held in violation of these GCR's.

Please be advised that refunds will not be processed until after June 14, 2010. Online withdrawals will be subject to a \$20.00 service fee.

### 12. Starting Order

It is the tradition of The Can-Jam Motorsports Black Bear Rally to conduct an open and public draw. This draw will be held at the monthly MLRC Mini Rally at the Husky House Restaurant, Intersection of Hwy. 400 & 88 (Exit 64A) at 1845 hrs on Monday, June 7, 2010.

The results of the Seeded Draw will be made available no later than June 10 on the event website.

As per NNR B.XI.B.1 (pages 49-50), The Organizers may, with approval of the Senior Steward, place any driver in a higher seed or in a specific position in the Start Order to reflect their demonstrated speed in previous stage events. If any competitors believe they should be moved to a higher seed than their current CARS seed group, they should provide results from previous stage rallies which demonstrate this, to the event organizer prior to the seeded draw.

### 13. Re-Seed

After the completion of the second stage, there will be a reseed and a regrouping of competitors. The revised starting order will be determined based on the results of the first and second stages (a total stage distance of approximately 16.5 km) in accordance with NRR B.V.C (page B-30). A second reseed may be conducted after the fifth stage (a total stage distance of approximately 56 km, subject to change)

### 14. Descriptive Stage Notes

The Can-Jam Motorsports Black Bear Rally will be offering organizer-written Descriptive Stage Notes to competitors prepared by Tom McGeer. These notes will be provided in a single format (similar to the US numerical format with turn and number. E.g.: L4 or R3 with a lower number indicating a tighter corner). A document describing the details of this format will be available on the Can-Jam Motorsports Black Bear web site under the Competitors tab and then selecting Descriptive Notes.

### 15. Optional Recce

Two-pass Recce of each stage road will be available. The first two stages will begin at 1630 hrs on Friday, June 11 at Rally Headquarters. The second two stages of Recce will begin at 0700 on Saturday, June 12 at Rally Headquarters. Please note that some stages will only be available to recce on Friday and others will only be available on Saturday morning. Any competitor on a stage road at any other time will be considered in violation of NRR VII H 1 (page B-41). The two-pass Recce is intended to allow teams to create their own stage/pace notes or modify the provided notes. Under no circumstances is this to be considered practice. Speeds will be controlled and monitored, with an outright maximum speed on any stage road of 60km/h or the posted limit, whichever is lower. Maximum speeds on transits will be limited to the posted speed limit. Radar enforcement will be in effect, and the use of radar detectors will result in exclusion from the notes familiarization pass.

Failure to comply with the maximum speeds during the Recce will result in penalties being applied by the Event Stewards up to and including exclusion for the first or following offenses. The first offense will be a \$100 fine, the second offense a \$300 fine and a third offense will result in exclusion from the event.

Rally vehicles will not be permitted on the Recce to reduce negative impact on the local population, however exceptions may be made on a case by case basis in consultation with the coordinator and senior steward. A document describing the details of Recce will be available on the Black Bear website under Competitors.

### 16. Awards

We would very much like to thank Can-Jam Motorsports, HotBits Sports Suspensions for their generous support of this year's Rally. In addition, we wish to thank ClearWater Design Canoes and Kayaks for their generous support of the event volunteers.

A complete list of all prizes and monies (if available) will be posted on the Official Notice Board prior to the opening of registration at 1600 hrs on Friday, June 11, 2010. Please note that prize money (if available) will be given in the form of a cheque or product gift certificates and mailed out to competitors along with printed results before June 26, 2010.

Prizes will be awarded to the winners of each class provided that a minimum of two entries have been received prior to the seeded draw.

## 17. Eligibility

To enter the Regional event, competitors need at least a CARS regional rally license or RA/NASA Club license. US competitors are asked to contact the CARS office directly for more information. To score points in the Ontario Performance Rally Championship, competitors must be members of a CARS/RSO club, and must indicate this RSO club on the entry form. A minimum of a St. John's Ambulance Emergency First Aid certificate, or equivalent, is required for all CARS-licensed competitors.

Each competitor must wear a head and neck restraint system which conforms to FIA standard 8858-2002. As of January 1, 2010 competitors are required to use homologated tethers that are identified by an FIA 8858-2002 label sewn on them. The head and neck restraint device should be considered as an ensemble which involves the seat, the harnesses, the head and neck restraint unit, its tethers and helmet. Effective April 1, 2009 competitors may wear the Hutchens Hybrid device, made by Safety Solutions. (This device has been approved for use by CARS based on projected FIA approval of this head and neck restraint device in 2009). See NRRs I A.7

## 18. Service Park

There will be a single service park beside Rally HQ. Competitors are advised that the service park will be open at 1600 hrs on Friday, June 11, 2010. Please note that there will be no trailer parking permitted in the service park. Trailer parking will be available close by. In addition, it may be impossible for large vehicles and/or trailers to enter the service area due to a narrow opening with a tight turn. Please be prepared to unload competition vehicles outside the service area.

At all times while a competition vehicle is parked in the service park a tarp at least the size of the car must be covering the ground under the car.

All Service Crews must have at least one fire extinguisher with a minimum UL rating of 40BC or two fire extinguishers with a minimum UL rating of 20BC each in their respective service area. The fire extinguisher shall be easily accessible and in an area visible to anyone within the teams' respective service spot. If requested by an official, evidence must be produced that fire extinguishers have been purchased or recharged within the preceding two years. – See NRRs VIII Service Crews, Section 9, Page B-43

The Service Park will be closed at 2300 hrs on Saturday June 12, 2010. All belongings and garbage should be removed prior to this time.

## 19. Refueling

There will be a designated refueling zone and ALL refueling must occur within this zone. No refueling is allowed in the Service Park except within this refueling zone. Fuel containers are to be deposited in designated locations in the refueling zone as soon as possible and prior to any servicing. When a fire service is not present, service crews must carry at least one fire extinguisher with a minimum UL rating of 10BC, other than the fire extinguisher on board the competition vehicle, to all refueling zones and remote/optional refueling zones.

## 20. Technical Inspection

Technical Inspection on Friday June 11, 2010 will be on a first-come, first-served basis from 1600 to 1800 and 2000 to 2200 hrs. Technical Inspection on Saturday June 12, 2010 will be by appointment only between 0700 and 0900 hrs. Please contact the scrutineers prior to Friday, June 11, 2010 to book an appointment (*see section 3*).

For each crew, a signed, self declaration will be submitted at the technical inspection that declares that the competing vehicle is a) road worthy and b) that the following items are operating properly:

- a) Running lights;
- b) Horn;
- c) Wipers;
- d) Reverse light;
- e) Brakes;
- f) Exhaust

The scrutineer may choose to verify compliance with any aspect of the self declaration. NRR XI F Page B-50, 51

Competitors who will be competing in a newly prepared car, or those that have not been issued a CARS/SCCA/RA/NASA logbook, MUST be inspected by the Scrutineers prior to the seeded draw or by prior arrangement with the Scrutineers.

## 21. Documents

The completed entry form must accompany the entry fee and must be signed by the Driver, Co-Driver and Entrant by the close of registration. All applicable documents must be available to be presented to the Registrar if requested and be valid on the day of the event. Vehicle Log Books for new competition vehicles must be obtained prior to the rally.

Rally licenses must be obtained prior to the rally. Canadian competitors should contact the CARS office at 905-640-6444 for license information. US Competitors should contact their sanctioning body and CARS.

## 22. Vehicle Identification

Door numbers will be provided at Technical Inspection. These must be applied to the satisfaction of the Scrutineers, and must be cleaned at every opportunity during the rally. There may be event sponsors who require their stickers be placed on competing vehicles. Our sponsors

are entitled to receive the full benefit of their advertising money. Please show your true appreciation of their support by displaying their advertising with pride. Please ensure your own sponsors are aware of these requirements. There are new door panel stickers available from CARS or RSO. These are available for a cost of \$10 a pair and some should be available at the event from the RSO Representative. The new RSO door numbers will be placed over the right side of the CARS panel.

### 23. **Timing and Safety Rules**

Timing of the rally will be as per the National timing system, NRR Section B.V (pages B-29 to B-35). Competitors should read this section carefully.

Competitors should also note the entire Safety Warning devices rule NRR VII.I.1 (pages B-41-42).

### 24. **Vehicle Spot Check**

The organizer or his delegate may elect to inspect any competing vehicle at any time during the event to ensure vehicle eligibility and safety. A time allowance will be provided to facilitate this inspection. In the event an infraction is found, the event Stewards will be notified.

### 25. **Accommodations**

Please consult our web site at <http://www.mlrc.ca/blackbear/> and select the Accommodations tab.

Competitors who have booked extra rooms or withdraw from the event are asked to cancel their accommodation bookings as soon as possible so that other competitors can use the space.

### 26. **Miscellaneous**

a) Route definition will be by tulip diagrams and metric (km) distances.

b) It is requested that Competitors and Service Crews refrain from using two-way radios near event radio cars as this may interfere with official rally communications.

c) Competitors who DNF will not be allowed to continue the event. No crew substitution will be permitted.

d) Please note: You may not bring alcohol into the Community Centre (location of the Awards Dinner and Ceremony) from an outside source, as this is in violation of LCBO and AGCO regulations.

e) Road Work Day - Competitors are invited to come out and help on this day. No rally vehicles are allowed, but it will give competitors an opportunity to assess road conditions and contribute to the event. Anyone planning to attend the Work Day should contact Ross Wood at 705-887-1130 or by email at: [ross.wood@sympatico.ca](mailto:ross.wood@sympatico.ca). All competitors are reminded that, with the exception of the Work Day, competitors are not permitted on the route within 60 days of the event, under NRR VII.H.1 (Page B-41).

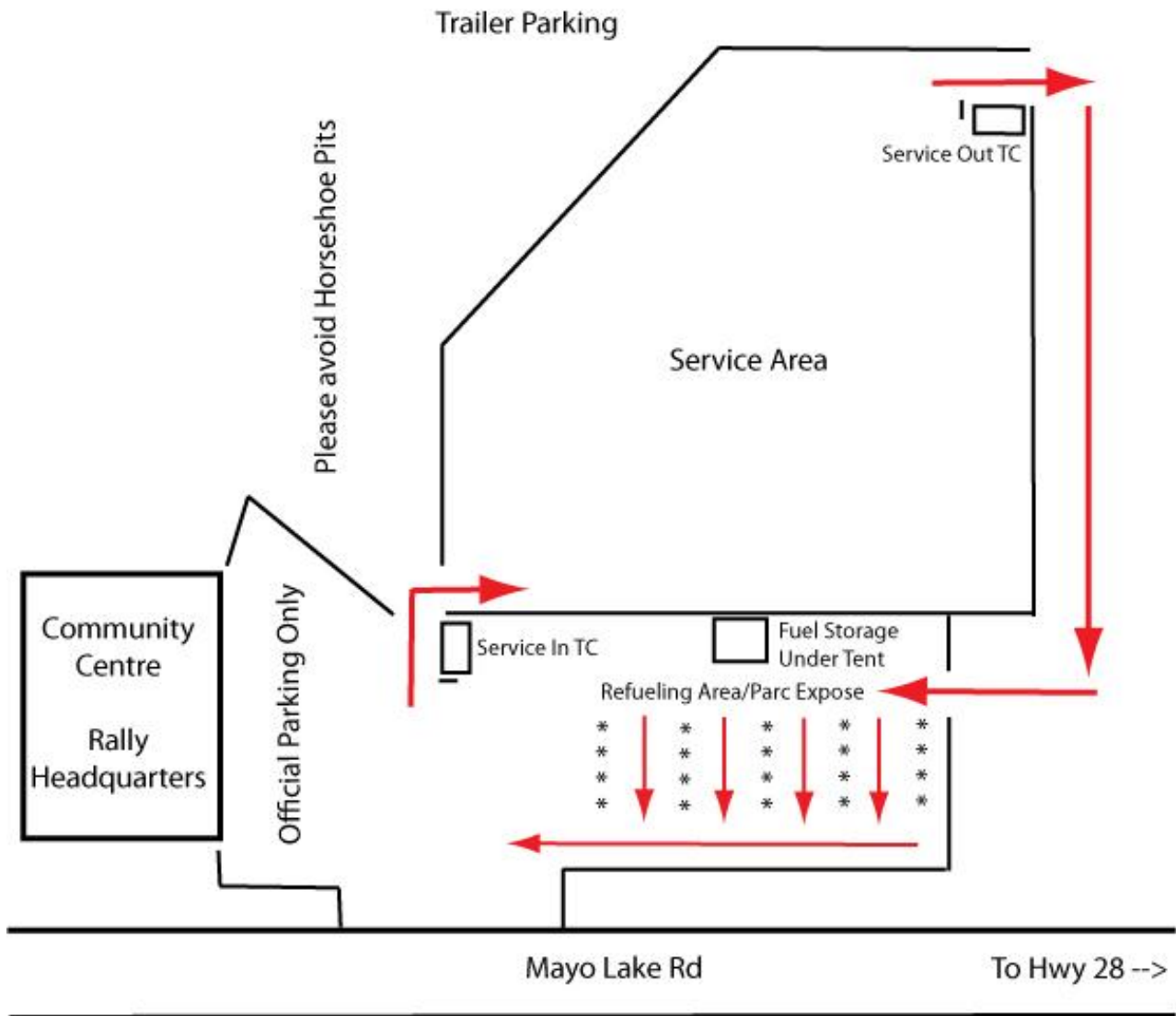
f) Event Officials, CARS Officials, Stage Captains, Control Marshals and other event marshals shall be considered Judges of Fact. As per the GCRs 6.3 b) (3), facts, other than those listed, shall be:

- Early arrival in a Control Zone
- Reversing in a Control Zone
- Servicing in a Control Zone
- Servicing in non-designated Service Areas
- Failure to properly wear safety harness, driving suit, helmet or head and neck restraint while traversing a stage
- Having open windows (no nets) during stages

g) Any inquiries regarding publicity and promotion for the rally should be addressed to the event coordinator.
